Monthly Recurring Charges (MRC)
Monthly payments for services shall be made through ACH and will process automatically on the first Monday of every month.

**Annual Recurring Charges (AOC)**Customers who wish to pay yearly, payments may be made in the form of a paper or electronic check or through ACH.

Access to Site and Facilities
Customer hereby grants Quad State Internet, LLC and its
contractors/partners access to its facilities, grounds, and physical
spaces for the purpose of installing, excavating, erecting,
maintaining, and/or upgrading ordered fiber-optic cable, ductor,
with a cuitement and services. Should the customer own the vaults, equipment and services. Should the customer own the premises, a permanent easement is hereby granted to Quad State Internet LLC for placing of said facilities.

Should the customer lease the premises, customer hereby certifies that it has secured permission from the landowner for running fiberoptics into their leased facilities and has notified the landlord and Quad State Internet as such.

Rate Adjustments

After the initial term, Quad State Internet, LLC has the right to increase rates by giving Customer 30 days advance notice of its intention to do so. Shall customer not agree to a rate change, customer may terminate its financial obligations within this contract within 30 days of the notice without penalty.

Nonpayment
Quad State Internet, LLC may terminate this Agreement upon 15
days of late payment unless other arrangements are made between
Quad State Internet, LLC and the customer at the discretion of
provider. Customer will be responsible for any collection charges.

Bankrupcy
Ouad State Internet, LLC may terminate this Agreement upon written
notice to Customer if Gustomer becomes the subject of a petition in
bankruptcy or any proceeding relating to insolvency, receivership, or
liquidation for the benefit of creditors, if such petition or proceeding is not dismissed within 60 days of filing.

### Changing Service Plans
